59. PUBLIC PARTICIPATION

Clerk informed that agenda is posted on the website and on noticeboards on main street and in Library windows. Generally posted on social media pages also.

Also, to notify via radio stations, Wrexham Leader and to send letters out to residents. Clerk explained that financial restraints would prevent postal notifications being sent but agreed that posters may be placed around the village depending upon permissions.
