89. CHAIRMAN'S COMMUNICATIONS

Cllr Price welcomed everyone to the meeting.

He reported that he and the Clerk had attended a meeting that day with a resident to discuss concerns about lighting on Smelt Road An item will be added to the agenda for March Full Council meeting to allow the resident the opportunity to discuss the lighting issues with the Full Council and hopefully reach a resolution.

- v) Clerk asked for better contact details and response times from Councillors and supplied sheet for them to complete to update contact details
- vi) Working groups met previous week for Staffing and Property items on agenda to cover matter which arose from working groups
- vii) Clerk informed Council she would be meeting with Anthony Wyatt and Cllr Childs next day to discuss Penygelli fields

- viii) Clerk informed Council of need to improve security system to include Council Office to allow staff to be able to view premises. This was highlighted by an incident the previous week when the police needed to be called to a person acting aggressively and issuing threats to staff.
- ix) Locum Admin role contract coming to an end and need to look at a permanent role with updated job description
- x) Clerk's role workload and need to formalise additional floating hours item to be addressed in Exclusion of Public and Press Staffing
- xi) IT Support although no action has yet been taken to gather further quotes, Clerk has identified that there are additional IT needs within the Council, going forwards and so further discussion needs to take place to look at what is required
