

Except for the matters reported below, on the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's/Committee's governance arrangements; and
- that the Council/Committee does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis of qualification

Accounting Statement

I am unable to conclude whether or not the Accounting Statement properly presents the Council's income and expenditure and financial position for the year:

- The Council has not provided the information required for me to complete my audit regarding the significant variances from the previous financial year.
- The Council has not maintained adequate accounting records for me to complete my audit.

Annual Governance Statement

In my opinion, the Annual Governance Statement is inconsistent with the Council's governance arrangements for the year:

- Assertion 1 approval of accounting statements. The Council did not make proper arrangements for the approval of the accounts in line with the timetable and requirements set in the Accounts and Audit (Wales) Regulations 2014.
- Assertion 4 exercise of electors' rights. The Council approved the annual return after the commencement date for the exercise of electors' rights. The Council should approve the annual return prior to the commencement of the inspection period and in accordance with statutory deadlines. Furthermore, the Council did not provide sufficient notice of the public inspection period as required by the Accounts and Audit (Wales) Regulations 2014.

Other matters arising and recommendations

There are no further matters that I wish to draw to the Council's attention.
